America Project



A few thoughts from member Lori Moodie in this Age of COVID

Despite the lockdown and huge scare of COVID, my life has been much more eventful (some good and some bad) than I ever imagined. It started with a 10-day, Carribean cruise with another retired teacher and two of our children. We left just as China was struck with COVID, but none in the U.S. – yet! While on the cruise, things became bad in the US, and it was discovered there were two crew members who had been on another ship with COVID. We feared that we'd be stuck at sea. Luckily, the two crew members tested negative and we returned home. That same day the cruising industry shut down and school closings were announced. We loved the cruise but were very grateful to be safe at home. What a way for my friend and her son to experience a cruise for the first time when I told her how wonderful cruises are!

The many closures caused my husband to be unemployed for a while. But while that door shut, another door opened. He got a new job doing essential work. During the pandemic, I've spent lots of time on Zoom with family and friends. I've had some nice WOEA-R Zoom activities. I went on a couple "safe from COVID" trips to Gatlinburg in my first new car in 15 years. I have done many long-awaited projects around my house. I also attempted to see my 80+ year-old parents a few times with a mask and at a safe distance.

I am very grateful that all my family, except one daughter have stayed COVID free. She was fairly miserable for ten days, but her youth got her through. Unfortunately, I've personally had to deal with two inpatient and 4 outpatient hospital experiences during all the pandemic restrictions. None of my family were allowed to be with me. Notes on the OEA Representative Assembly - submitted by Sandy Coe

On December 5th, 750 delegates at the RA discussed events of 2020, the impact of COVID-19, current legislative efforts, organizing and advocacy successes, and more. President Scott DiMauro addressed COVID-19's impact on the educational system in Ohio and the fight for the safety of our members and students. Newly elected NEA President Becky Pringle thanked us for battling some of the systemic social problems our country continues to face. Vice President Jeff Wensing reviewed legislative undertakings in our General Assembly, their importance, how they affect OEA, and how we can support issues important to us. Secretary-Treasurer Mark Hill enumerated OEA's financial and membership numbers. The delegates also heard OEA's new Executive Director Patricia Collins Murdock. She expressed her admiration for all the hard work and commitment that the delegates have demonstrated. A bittersweet moment was the tribute to outgoing Executive Director Sheryl Mathis. NAACP

WOEA-R became a Life Member of the NAACP in 2020.

The NAACP or National Association for the Advancement of Colored People was established in 1909 and is America's oldest and largest civil rights organization. It was formed in New York City by white and Black activists, partially in response to the ongoing violence against African Americans around the country. In the NAACP's early decades, its anti-lynching campaign was central to its agenda. During the civil rights era in the 1950s and 1960s, the group won major legal victories, and today the NAACP has more than 2,200 branches and some half a million members worldwide.

The NAACP was established in February 1909 in New York City by an interracial group of activists, partially in response to the 1908 Springfield race riot In Illinois. In that event, two Black men being held in a Springfield jail for alleged crimes against white people were surreptitiously transferred to a jail in another city, spurring a white mob to burn down 40 homes in Springfield's Black residential district, ransack local businesses and murder two African Americans. The NAACP's founding members included white progressives Mary White Ovington, Henry Moskowitz, William English Walling and Oswald Garrison Villard, along with such African Americans as W.E.B. Du Bois, Ida Wells-Barnett, Archibald Grimke and Mary Church Terrell.
