# More human trafficking notes

<u>Definition of human trafficking:</u> Taken by force, fraud or coercion against their will, at any age, to do what they don't want to do. Children and adults can be human trafficked.

Susan's group is starting by focusing on looking for children age 17 years old because once they turn 18 they don't have to do anything or go with them. The Soroptimist club of Dayton has found all the children on the lists they have created so far. They distribute lists, with photos of the missing, to restaurants, stores, salons, rest stops, hotels, etc. They mostly put these in staff rooms across the Miami Valley because the employees are the ones who see the missing kids when they are often brought to these facilities. The Soroptimists have been successful in finding all the children on the lists so far. The pictures are instrumental in helping them to find them. Actually, they don't put a person's name on the list unless they have a picture. There is a hotline to call if you see something going on, but don't get involved yourself in the situation.

The Soroptimists of the Miami Valley are setting up groups in other cities and states too. These lists can also be put onto phones, social media, etc. This shows the missing kids that everyone cares and wants them to be ok.

Most of these kids have been beat up until they do what they are told to do. Sometimes it's even parents or siblings who are trafficking their own children or siblings for drugs.

There are some agencies to help trafficked people. For example, "Safe Harbor" covers every aspect of the missing children's lives (social, emotional, physical, religious, etc). Oasis House helps people 18 years and older. Susan Greenburg said that Mother Teresa said, "We can't all do great things, but we can all do small things with love."

There is a new law to help with the trafficking problem: You can be arrested if you are giving kids drugs (Ex: The traffickers say to these missing children that if you want another hit, you'll do as I say). This is trafficking.

The pornography on the digital world has increased this problem by 800%. Traffickers give gifts, etc. to bring them in. They threaten to hurt their parents, siblings, etc. if you don't do as they say. The Soroptimists will be putting stop signs with hotline numbers in all restrooms at all the rest stops in the Miami Valley. You can also get them for schools and businesses too. Susan is covering all hotels from Austin Blvd to Troy. She has a driver in case she doesn't come out within 15 minutes. This group has been here for 4 years. Four of the hotels Susan goes to use the checklist they pass out for training their employees. Trafficking is normally about making money.

There are 3 efforts of the Soroptimists International of Dayton are:

1. Prevention, 2. Education, 3. Rescue

They want the found children to feel good about themselves, live their dreams, etc. Some traffickers traffic babies. They have sex with them. Some of those trafficked come from homes where there are generations of trafficking going on, so they think this is the way of life, since this is all they know in their families. There are a lot of Asians who are brought to this country with promises of a beautiful home, etc. if they do sex acts, etc for their perpetrator (This tends to happen a lot in hotels, nail salons, restaurants, etc).

- -Susan Greenburg goes to a preschool where they pray for the missing kids. Susan always takes prayers.
- -Human trafficking is really big in Dayton (especiall because of the I-70 & I-75 corridor).
- -People sell themselves to make money.
- -Women, men and senior citizens are even trafficked. Ex: Traffickers especially go after those who are on a limited income and do things like offer them a job watching their kids and then eventually tell them they can move in with them. Things go well at first, and then the home owner talks the person into the basement and won't let them out and then they abuse them.
