

Since his inauguration on January 20th, President Donald Trump has issued several dozen Executive Orders. As a result, his Administration is facing more than 75 lawsuits. He has stated his intention of eliminating the Department of Education. The question for us to consider is:

What lies ahead for public education in the United States if the Federal Department of Education is eliminated?

For the Good of the Group

If the DEPARTMENT of EDUCATION is ELIMINATED...

It's a Cabinet department, instituted by Congress, with a \$79 billion budget, administers aid to schools across America and ensures students' rights to equal education.

President Trump's Secretary of Education nominee, Linda McMahon, (a relative unknown in education circles) has recently been approved by a Senate committee. His plan is to have her wind it down, then urge Congress to abolish it. "I want Linda to put herself out of a job..." President Trump has promised to close it, saying "...it has been infiltrated by radicals, zealots and Marxists," What will happen?

- Scott DiMauro, OEA President, reported that the Department accounts for 11% of all public school revenue in Ohio last year, according to a recent Ohio Legislative Budget Office report. These grants fund more than a dozen programs that support impoverished and low achieving students, early learning and preschool, homeless children, free meal programs for hungry students, rural education, career and technical grants, neglected and delinquent children, and more than 61,000 English learners.
- > Oversight Enforces laws like the Individuals with Disabilities Education Act (IDEA), which mandates that students with disabilities receive free appropriate public education (FAPE). If the Department were to be dismantled, enforcement of IDEA and other related laws could become fragmented or inconsistent.
- ➤ Equity The quality of services for students with disabilities could vary dramatically from state to state. The inequality that would result could leave many students vulnerable, further exacerbating the disparities in educational outcomes for this population.
- Advocacy Plays a vital role in advocacy for marginalized groups, including students with disabilities. Without this national platform, students and families would likely struggle to have their voices heard in policy discussions at the federal level.
- Support Upholds the civil rights of students with disabilities. It ensures that students are not discriminated against based on their disability and that they have access to the same educational opportunities as their peers. Students with disabilities could face increased challenges in securing the accommodations they need to participate in school activities, leading to further isolation and disadvantage.
- > Structure Long-term planning and programs for students with disabilities would be thrown into flux, as current policies and structures might no longer be upheld. Lack of coordinated federal oversight could result in confusion, inefficiency, and missed opportunities for students with disabilities.
- Assessment Without a centralized source of data collection, research, and recommendations, it would be difficult to assess how well students with disabilities are doing. This would result in a lack of accurate information about needs, progress, and potential, making it harder to improve outcomes for these students.
